object of the declaration: It serves as a conduit boxes into hollow walls eg. of drywall or wood paneling. It is made with breakable membrane or inputs. Preferably membrane inputs perfect sealing of cables or pipes, ensuring airtight boxes. This feature leads to lower heat losses and near boxes stain direct drafts, which carries with it the dust. The boxes are made of fire-retardant material to abnormal heat and fire, which is verified by a test with flaming loop 850 ° C according to the applicable standard EN 60 670-1. Based on the positive results of this test are electrical boxes into hollow walls classified by installation class 7.2.1.2 - like recessed, semi-recessed or stored in combustible walls, ceilings in flammable or combustible floors. Furthermore, these boxes are classified in Class 7.2.1.3 as recessed, semi-recessed or stored in the hollow walls and hollow ceilings, hollow floors or furniture. Minimum and maximum temperatures during installation are -5 ° C to + 60 ° C. The IP 30 enclosures meet the enclosure fitted with the appropriate lid or device with a coverage equal to or higher than IP 30. The boxes are delivered with screws.
